Ms. Cabral has over 20 years of experience in a wide range of areas that include public affairs, administration, board services, and wastewater industry relations. Her professional experience includes development and implementation of award-winning proactive public participation and community outreach programs. Jennifer was instrumental in developing the Construction Outreach Program to support OC San's \$3 billion Capital Improvement Program to inform and connect with over 2.6 million residents as well as getting Assembly Bill 2022 signed into law which allowed for the bottling of the Groundwater Replenishment System water for education purposes.
